TO ALL MUNICIPALITIES IN THE PROVINCE OF THE WESTERN CAPE

REMUNERATION OF CHAIRPERSONS AND MEMBERS OF VALUATION BOARDS AND VALUATION APPEAL BOARDS

1. Regulations and instructions issued in terms of the Exchequer Act, 1975 (Act No. 66 of 1975), has been repealed in terms of section 76 of the public Finance Management Act (Act 1 of 1999).
2. You are referred to the remuneration of the chairperson and members of the valuation board as prescribed in section 3(7) of the Property Valuation Ordinance, 1993, as well as the remuneration of the chairperson and members of the valuation appeal board as prescribed in section 5(7) of this Ordinance.
3. In terms of the new Treasury Regulation 20.2.2 the following maximum remuneration scales regarding the payment of non-official members were approved:
