INGXELO NGALE NKQUBO

1. Nawuphi na umqeshi kufanelekile ukuba athabathe amanyathelo afanelekileyo okukhusela impahla yakhe, ngoko ke unelungelo lokusetsha abasebenzi kwaneempahla zabo.
2. Iziphatha-mandla zoLawulo lwePhondo leNtshona Koloni (WCPA) zonoxanduva lokugada impahla yorhulumente ikhuseleke. Oku kuya kwenziwa ngokwemiqathango yoMgaqo-siseko woMzantsi Afrika (Act 108 of 1996), lingalithalwanga ilungelo elilodwa labucala lomntu ngamnye. ICandelo 36 loMgaqo-siseko ke ngoko, likhankanya ukuba eli lungelo liya kuba nemida ethile ngeenjongo zomthetho, ekufuneka zijongiwe, kwaye loo mida yenziwe ngokufanelekileyo ngaphezulu inezizathu.

INKQUBO

1. Ngenxa yomonakalo, ukwanda okukhulu kweziganeko zokulahlekelwa, zithe iziphatha-mandla emva kokuba ziye zacingisisa zenza nophando ngokupheleleyo, zagqiba ekubeni ukusetsha yeyona ndlela ifanelekileyo ukugatya ubusela.
2. Kuya kusetshwa kusetyenziswa iindlela ezimbini kugatywa kukwanqandwa ubusela.
 - (a) Luya kwenziwa ugqogqo maxesha onke kwiindawo ezinesantya esiphezulu zesi senzo. Ezo ndawo zinjalo zichazwa njengeendawo, umzekelo, apho izinto ezincinci nezizezexabiso zinokubeka lula.
 - (b) Kuya kuvele kusetshwe kungalindelwanga kwiindawo ezinesizathu esibambekayo nenkolo yokuba ziyabiwa kuzo iimpahla iziphatha-mandla, ngenxa yokufumana isilumkiso esithile, kungenjalo amanyathelo okukhawulelana nokugatya ubusela. Zininzi iindlela zokuthatha isigqibo sokuba ngubani na omakasetshwe, umzekelo xa imabhile zili-10 engxoweni kukho nenombala owahlukileyo, umntu ke othe wafumana leyo yahlukileyo kwezinye uya kusetshwa.
 - (c) Kuya kuxhomekeka mayela nemfuneko yokuba kufakelwe izixhobo zokuchupha, oko kusenziwa ngokwezigaba ezahlukeneyo ngaphandle kwesilumkiso.

NGOKUBANZI

1. Abasebenzi abathe bafunyanwa benempahla yakwaPAWC ngokungekho mthethweni, baya kujongana nenkqubo yoluleko yesebe elichaphazelekayo kwanobutyala bolwaphulo-mthetho. Ityala ngalinye liya kugqithiselwa kwabeNkonzo yaMapolisa yoMzantsi Afrika (SAPS) ngokuhambelanayo noMgaqo-nkqubo woBuqhetseba noBusela.
2. Ukuba ngaba uye wakrokrela msebenzi uthile unogada ukuba uneempahla zorhulumente ngokungekho mthethweni, aze umntu lowo ale ukusetshwa, kuya

kubizwa abeNkonzo yaMapolisa oMzantsi Afrika ukuba bamsetshe ngokwabo. Ukungavumi ukuthobela inkqubo yosetsho, loo nto iya kukhokelela ekubeni umntui lowo athatyathelwe amanyathelo oluleko.

3. Bonke abasebenzi kwanabandwendweleyo, bayacelwa ukuba bancedisane noonogada ekwenzeni umsebenzi wabo ongelula, ngokuthi bavumelane neenkqubo zokusetshwa.
4. Bonke abasebenzi kufuneka bazazi iziphumo ezingancumisiyo xa benokufunyaniswa benobutyala bobusela, okanye ukuba neempahla zeWCPA ngaphandle komthetho.
5. Nawuphi na unogada we-WCPA okanye unogada wabucala olisebenzisa ngokungafanelekanga igunya analo ngokwemiqathango yale nkqubo, uya kuthathelwa amanyathelo angqingqwa oluleko. Izikhalazo ezibekho ngenxa yezenzo ezinjalo mazithunyelwe ngokwencwadi ebhaliweyo kwiNtloko yoLawulo loThintelo-ngozi yeSebe/yeziko.
6. Ugqogqo oluya kwenziwa ekhaya luya kwenziwa ngaMapolia eNkonzo yoMzantsi Afrika, kuphela emva kwengxelo efunyelweyo nguloo mntu uthe weza nengxelo ngento ekrokrisayo. AbeSAPS baya kufumana ilungelo (warrant) lokugqogqa ze bakwenze oko behamba noonogada be-WCPA okanye unogada wabucala.
7. Zonke izithuthi (kuqkwa nozorhulumente) ziya kugqogqwa. Abasebenzi kuya kufuneka babavumele abe-WCPA, kungenjalo unogada wabucala ukuba asetshe isithuthi ngaphakathi nakwiindawo ezitshixwayo ezinjengeebhuti ezi.
8. Kwiimeko kaxakeka ilokhari/isefu (locker) engaphawulwanga okanye mhlawumbi akafumaneki umniniyo, iya kuvulwa emva kokuba sele ekhangelwe nkalwana zonke. Kwiimeko ezingxhalabisiyo ilokhari/isefu kufuneka ivalwe ize ibe selugcinweni loonogada. Xa ngaba lo lokhari/ isefu ayide ilandwe emva kweentsuku ezisixhenxe iselugcinweni, oonogada baya kuyivula phambi kweNtloko yeSebe/ yeziko.

14. Uggogqo oluya kwenziwa ekhaya luya kwenziwa ngaMapolia eNkonzo yoMzantsi Afrika, kuphela emva kwengxelo efunyelweyo nguloo mntu uthe weza nengxelo ngento ekrokrisayo. AbeSAPS baya kufumana ilungelo (warrant) lokugqogqa ze bakwenze oko behamba noonogada be-WCPA okanye unogada wabucala.
